<u>Session Description</u>: Owners of every successful privately held company eventually must decide on a business transition – either retain the business (i.e., transfer ownership to the next generation), or monetize it (options include a sale to a private equity firm or strategic buyer). In this session, we will provide an overview of the middle-market transaction environment (touching M&A and credit markets, and financial sponsor activity), key long-term objectives and challenges facing a private business owner, ownership transition options, the M&A process, and more.

Session Description: A review of the latest trends and examples of fraud schemes including cyberattacks and ransomware, what to do if and when your company becomes the target of an attack, and best practices for companies to protect themselves.

Alec Grant is the Head of Client Fraud Prevention, a newly established role within CB Global Services, reporting to Dan Wilkening. The CB Global Services Fraud Prevention function is responsible for designing and delivering strategies to protect both the firm and its clients from losses. By driving forward the future of fraud detection through AI models and data analytics, the team seeks to enhance client experience and increase recovery rates across all products and channels – including client education, electronic payment, check and card fraud risk.

Alec brings 15 years of experience in building and executing fraud, financial crime, and operational risk strategies. Most recently, he was at Barclays, where he was responsible for Global Fraud Management. Alec has also done similar work at Royal Bank of Scotland (RBS) and has a track record of implementing innovative solutions to combat fraud across both Corporate and Consumer segments.

In addition, Alec is a sought-after industry expert who previously sat on the Global MasterCard Advisory Council, was the Chair of Financial Fraud Trade Association, a former member of the UK Joint Fraud Task Force, chaired by the Home Secretary, and was the former Money Laundering Reporting Officer of Barclays Retail Bank.

Topic: New Direction for I90 Corridor: Building a Competitive and Equitable Business Ecosystem

Speakers: Marco Villegas, Vice President, Global Philanthropy – JPMorgan Chase & Co -and-Benjamin Sio, Chief of Staff and Senior Vice President of Strategy, Policy and Planning – CenterState Corporation for Economic Opportunity -and- Simeon Banister, President and CEO – Rochester Area Community Foundation

<u>Session Description</u>: It's important that decision makers and influencers within their organizations have a key understanding of their company's ESG policy, their ESG investment plans, and the impact of those investments in the region. In this session, JPMorgan will moderate a panel of speakers that will include Benjamin Sio from CenterState CEO, as well as Simeon Banister from the Rochester Area Community Foundation to expand on persistent gaps in the small business ecosystem, collaboration opportunities across the region, and the tech hub application and implications for the region.

As a highlighted example, CenterState CEO solidified and activated a regional partnership across public and private sector to create conditions for new business growth, with a focus on developing economic opportunities in growing sectors. Their collaboration ultimately contributed to Micron's \$100 billion commitment to the region.

Along with state government, community foundations, and private sector, CenterState CEO has been working on an application for up to \$75 million in Federal grants for tech hubs across the region and have been working closely with Micron on building out the inclusive supplier network across the region.
